**Class aims:** To introduce the interdisciplinary research areas and portfolio of Prof. Tim K. Mackey and his team at UCSD in global health, international policy and governance, and health technology. The aim of this talk is to explore potential cross discipline and cross country collaborations in the area of global health, public health, and medicine.

**Content:** The lecture will cover the types of research conducted by Prof. Mackey's lab comprised of team members with background in public health, policy and law, and computer science. Examples of research conducted and published in different domains will be explored, along with discussion of advocacy, existing collaborations, and international cooperation activities (including with the World Health Organization). The talk will also discuss the courses taught by different members of Prof. Mackey's team at UCSD and research tools and analytical platforms used by the team to enhance their research productivity.

**Expected outcomes:** The objectives of this lecture are to introduce the different topics and methodologies that Prof. Mackey's team are engaged in and build pathways for possible research collaborations, education and capacity building between UCSD and Kyoto University.

Class aims: To describe and assess basic strategies on how to effectively publish in the peer review.

**Content:** This 1hr lecture will provide a basic overview of the key principles of publication strategy and planning. This includes discussion about different content types, how to do journal targeting, quick tips on how to respond to reviewers, research tools and software, and discuss the importance of dissemination of research.

**Expected outcomes:** Students should understand the basic principles of publication strategy and be able to apply these skills in a longer workshop where they will create a research portfolio outlining their individual research plan.

Readings and exercises: Since this is a short 1hr lecture, there are no required readings or assignments. The talk will discuss the readings, examples, and interactive exercise for the full workshop as background and for possible further engagement.

Tim Ken Mackey is the Director of GHPi, an Associate Professor of Anesthesiology and Global Public Health at UC San Diego School of Medicine, and is the Associate Director for the UC San Diego MAS Program in Health Policy & Law. He holds a BA in Political Science-International Relations and a Masters Degree in Health Policy & Law from UC San Diego and also earned his PhD in Global Public Health from the joint doctoral program at UC San Diego - San Diego State University. His work focuses on a broad array of multidisciplinary topics in domestic and global public health. This includes cross-cutting research in disciplines of public health, medicine, international relations, public policy, law, innovation, substance abuse, eHealth, crime, and global governance. He has extensive professional experience including consulting for the World Health Organization, the US Department of State and others. He is currently the Section Editor of Global Health, BMC Public Health and the Editorial board of Global Health Governance, Blockchain in Healthcare Today, Medicine Access @ Point of Care, and BMC Medicine.
